Article IV, Section 1, Composition;

 One Department Head, one District Director and one AREC Director, each elected by their peers – non-voting

Article VI, Section 7a. Committee on Academic Program Policy, Membership:

- Seven Faculty members elected by the Faculty Association to represent a cross section of department and disciplines. Faculty will serve 2-year terms.
- The members will elect the chair
- A student selected from the CALS Graduate Committee

Section 7b. CALS Curriculum Committee

• To review undergraduate and graduate course proposals, check sheets, changes in curriculum, new academic programs, including education abroad,

and review of materials on 15-day review from other colleges. In regards to material on 15-day review from other colleges, committee members will disseminate this knowledge to other members of the CALS Faculty and staff to be sure a broad audience is aware of program or courses proposed by another college.

Membership:

 One faculty member from each academic unit to be nominated by the department head and selected by the director of academics programs to represent a cross section of department and disciplines. Faculty will serve 2year terms.

Section 8. Committee on Extension and Research Program Policy Membership:

- Five members elected by the Faculty Association, to include one from an AREC, to represent a cross section of department and disciplines. Faculty will serve 2-year terms.
- The members will elect the chair

Section 9. Committee on International Program Policy

One agent faculty <u>and one Extension Specialist</u>, elected by VESA

There being no further discussion, a motion was made to approve the constitution as amended; it was seconded. The Constitution was approved.
